General product application requirements:

- Recycling:** SAL encourages recycling, please consider the environment when disposing of packaging & components.
- Switching or test intervals:** For optimum product performance, good design practice does not encourage 24/7 operation of lighting products without the provision of a routine switching or regulatory test cycle. As a guide for continual operation installations, a twelve (12) hour duration for Industrial and Commercial applications and a six (6) hour duration for Residential applications should be considered.
- Product maintenance:** In line with the relevant design standards and to protect your investment, it is important to have in place a routine cleaning program that reflects the installation environment and maintains the product in a clean and functional condition.
 IMPORTANT - The supply must be isolated before any product maintenance or cleaning is conducted. In addition, damage to ANY cable or cord supplied with the product must be addressed as follows; For attachment type X having a specially prepared cable, if the external flexible cable is damaged, it must be replaced by an equivalent cable exclusively available from the manufacturer or authorised installer. For attachment type Y, if the external flexible cable is damaged, it must be exclusively replaced by an equivalent cable by the manufacturer or authorised installer. For attachment type Z, if the external flexible cable is damaged, the cable cannot be replaced and the luminaire must be destroyed.
- Adverse, corrosive and coastal installation environments:** Unless the product is specifically designated for such applications in these installation instructions, which is supported by a professional maintenance program; installation of equipment in such environments is not recommended.
- Dimming products:** Dimming circuits and product compatibility must be validated by the installer before installation; SAL cannot be responsible for third party changes in dimmer compatibility.
- Suspended products:** For installation safety, any suspended products must NOT be installed in high air movement spaces or locations subject to impact.
- Light source replacements:** (non-replaceable light sources) - The light source of the product is deemed not replaceable, when the product reaches its end of life, the complete product must be replaced by a qualified installer. (non-user replaceable light sources) - The light source of the product must only be replaced by the manufacturer or qualified installer. Caution, risk of electric shock.
- Interior downlights and sensors with remote drivers:** The mounting facilities provided for the transformer/driver (if any), need only be utilized if in the application of the product is required by AS3000. Drivers are not designed for installation environments that restrict conventional airflow.

9. Specific installation procedures:

PIXIE SGB/BT introduction:

The PIXIE Signal Booster is a USB powered device that can plug into standard USB port, working under DC 5V 1A. The device is designed to expand the signal coverage of the PIXIE network, maintaining a consistent wireless signal within PIXIE system.

Technical Specification, Wireless: Bluetooth Low Energy Technology, input USB DC 5V 1A, IP20

Installation Instructions:

IMPORTANT (1) For optimum signal communication, the maximum distance between a PIXIE device and the controlled device is 15 metres. IMPORTANT (2) One (1) PIXIE HOME can use a maximum of 10 x SGB/BT devices.

1, ESTABLISH A HOME FOR THE BOOSTER – Select a position within the installation, where the signal booster can be located centrally and no further than 15 metres from a PIXIE device.

2, INSTALLATION – Insert the Signal Booster into standard USB port (DC 5V 1A), initially the LED indicator is in white colour.

3, PAIR THE BOOSTER – Open the PIXIE app via your smart phone device, then select "Device" -> "Add device", which will then search for the signal booster. Once identified add it into the app and when the LED indicator on signal booster turns blue, it is paired.

Device features:

1. The SGB/BT LED indicator can be turned off if required. **To turn off the LED indicator:** Quickly click the button 7 times to totally turn off LED indicator.

2. To initiate a **factory reset for the device**, quickly click the button 9 x times, the LED indicator will change to white when successful

10. Warranty: In accordance with SAL's standard terms and conditions of sale, SAL warrant this product to be free from defects in materials and or workmanship for a period as stated below for goods not subject to incorrect installation, maintenance, operation, mishandling, environmental, unauthorised modifications or electrical operating conditions outside the nominated product specification as detailed in these installation instructions.

How to make a claim?
